SCHEDULE 13G

This Schedule 13G (this “Schedule 13G”) is being filed on behalf of Scott Lake Energy, L.P., an Oklahoma limited partnership (“Scott Lake”), Scott Lake Energy, LLC (“Scott Lake LLC”), an Oklahoma limited liability company and the General Partner of Scott Lake, and Mr. Donald Rowden, the manager of Scott Lake LLC, relating to the common stock, \$0.001 par value per share (“Common Stock”) of Lucas Energy, Inc., a Nevada corporation (the “Issuer”).

This Schedule 13G relates to shares of Common Stock of the Issuer received by Scott Lake pursuant to the August 25, 2016 closing (the “Closing”), of the transactions contemplated by that certain Asset Purchase Agreement, entered into between the Issuer and twenty-three sellers (collectively, the “Sellers”), including Scott Lake, as a Seller, and Segundo Resources, LLC, as a Seller and as a representative of the Sellers named therein (the “Representative”), dated December 31, 2015 (as amended to date, the “Purchase Agreement”). Pursuant to the Purchase Agreement, the Issuer acquired working interests in producing properties and undeveloped acreage in Texas and Oklahoma, including varied interests in two largely contiguous acreage blocks in the liquids-rich Mid-Continent region of the United States, and related wells, leases, records, equipment and agreements associated therewith (collectively, the “Assets”), from the Sellers (the “Acquisition”). In consideration for the purchase of the Assets, the Issuer assumed approximately \$30.6 million of commercial bank debt, issued the Sellers (a) 552,000 shares of Series B Redeemable Preferred Stock (“Series B Preferred Stock”)(convertible into 3,941,280 shares of Common Stock, the “Series B Preferred Stock”) and (b) 13,009,664 shares of restricted Common Stock (of which 820,968 shares were issued to Scott Lake); and (ii) paid the Sellers \$4,975,000 in cash.

As General Partner of Scott Lake, Scott Lake LLC, may direct the vote and disposition of the 820,968 shares of Common Stock held by Scott Lake. As the manager of Scott Lake LLC, Mr. Rowden may direct the vote and disposition of the 820,968 shares of Common Stock held by Scott Lake.

- (a) Scott Lake is the beneficial owner of 820,968 shares of Common Stock. By virtue of their relationship with Scott Lake, discussed in further detail above, each of Scott Lake LLC and Mr. Rowden, may be deemed to beneficially own the shares of Common Stock beneficially owned by Scott Lake.
- (b) Scott Lake is the beneficial owner of 5.3% of the outstanding shares of Common Stock. This percentage is determined by dividing 820,968 by 15,449,206, the number of shares of Common Stock issued and outstanding as of September 1, 2016, as confirmed by the Issuer's Transfer Agent on such date. By virtue of their relationship with Scott Lake, discussed in further detail above, each of Scott Lake LLC and Mr. Rowden, may be deemed to beneficially own the shares of Common Stock beneficially owned by Scott Lake.
- (c) Each of Scott Lake LLC and Mr. Rowden may be deemed to have shared power with Scott Lake, to vote and dispose of the 820,968 shares of Common Stock held by Scott Lake.
